ZONING ORDINANCE AMENDMENT RESOLUTION ADOPTION

At a special meeting of the Columbia Township Planning Commission, Tuscola County, Michigan, held on 16th day October 2019, at 7:00 p.m., the following resolution was offered by STING and supported by Dehmel.

WHEREAS, the Columbia Township Planning Commission has been working on a proposed Zoning Ordinance Amendment for the Township; and

WHEREAS, proper notice of the public hearing was published in the Tuscola County Advertiser on the 28th day of September 2019; and

WHEREAS, the public hearing on the proposed Zoning Ordinance Amendment was held on the 16th day of October 2019 at the ACW - Unionville Fire Station at 6454 Merry St., Unionville, MI 48767; and

WHEREAS, all the requirements of the Michigan Zoning Enabling Act, being Public Act 110 of 2006 as amended, have been complied with; and

NOW, THEREFORE, be it resolved that the Columbia Township Board of Trustees hereby recommends the adoption of the attached proposed Zoning Ordinance Amendment.

BE IT FURTHER RESOLVED that a Notice of Adoption shall be published within fifteen (15) days and that the Ordinance shall take effect seven (7) days after the publication date.
